INVITATION FOR BIDS

1. The Government of the United Republic of Tanzania has received a credit from the International Development Association (IDA) in various currencies towards the cost of the Dar es Salaam Metropolitan Development Project (DMDP). It is intended that part of the proceeds of this credit will be applied to eligible payments under the contract for **the Construction of Investment Sub-Projects in Mburahati Ward (Kisiwani and Barafu Sub-wards and Tandale Ward (Mtogole and Sokoni Sub-Wards))**.
2. The Municipal Director, Kinondoni Municipal Council now invites sealed bids from eligible bidders for **the Construction of Investment Sub-Projects in Mburahati Ward (Kisiwani and Barafu Sub-Wards and Tandale Ward (Mtogole and Sokoni Sub-Wards))** with major items of work as tabulated below. The works must be completed within 15 months.

- Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the World Bank's Guidelines: *Procurement under IRBD Loans and IDA Credits* (Current Edition) and is open to all eligible Bidders as defined in the guidelines.
- Qualifications requirements for the works include: (i) experience as prime contractor in construction of at least two works similar nature and complexity in the last five years (ii) minimum annual volume of construction work for the last five years of **USD 16 million** or equivalent (iii) minimum amount of liquid assets and/or credit facilities net of other contractual commitments of **USD 3.0 million** or equivalent, etc.
- Interested eligible bidders may obtain further information from Kinondoni Municipal Council and inspect the bidding documents during office hours from 07.30 to 15.30 hours local time, Monday to Friday inclusive at the address given below.
- A complete set of Bidding documents in English may be purchased by interested bidders on submission of a written application to the address below and upon payment of non-refundable fee of **Tanzania Shillings Two Hundred Thousand Only (TZS200,000.00)** or its equivalent in freely convertible currency for each set, payable by Banker's cheque, Bankers Draft or Cash to **Municipal Director, Kinondoni Municipal Council, 2 Morogoro Road, P. - Bids must be delivered to **The Secretary, Municipal Council Tender Board, Kinondoni Municipal Council, Office of the Procurement Management Unit (PMU), Room No. 1, 2 Morogoro Road, P.O. Box 31902, 14883 Dar es Salaam, Tanzania** on or before **10:00 am on Thursday February 15, 2018**. Electronic bidding **will not** be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at **Kinondoni Municipal Conference Hall, 2 Morogoro Road, Dar es Salaam, immediately after the deadline for submission of Bids.**
- All bids must be accompanied by **Bid Security of TZS. 450,000,000 (Tanzanian Shillings Four hundred fifty Million Only)** or an equivalent amount in freely convertible currency **valid for 28 days beyond the bid validity period**. The Bid Security shall be an

Unconditional Bank Guarantee or Irrevocable Letter of Credit or Banker's Cheque clearly addressed to: **The Municipal Director, Kinondoni Municipal Council, 2 Morogoro Road, P.O. Box 31902, 14883 Dar es Salaam, Tanzania.** Bids will be opened in the presence of bidders' representatives who choose to attend immediately after submission.
